**MEMORANDUM OF UNDERSTANDING

This Tie-up Agreement is made on 01.08.2025, between Shri Janardhan Swami Homeopathy Hospital & Research Center, having address A/p. Kokamthan, Tal. Kopargaon, Dist. Ahmednagar Hereinafter referred to as (which expression shall unless it be repugnant to the context or meaning thereof shall deem to mean and include its successors and assignees)

And

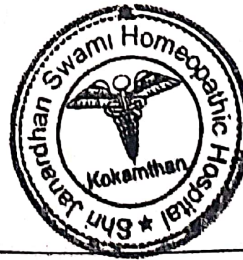
Mr. Mahesh Raktate, Ambulance Services having its address at Kanchanwadi, Kokamthan, Kopargaon, Pin - 423 601, hereinafter referred to as Ambulance service provider [ASP] (which expression shall unless it is repugnant to the context or meaning thereof shall deem to mean and include its successors or assignees).

WHEREAS, Hospital is a providing various health related services to their clients which includes amongst them insured individuals and groups, corporate, self-funded groups, foreign travelers and insurance companies and for this purpose Hospital has created a network of service providers.

The ASP agrees to provide the necessary services on the terms and conditions, herein after appearing:

• SCOPE OF SERVICES

1. ASP will be responsible for providing its Ambulance services as specified by Hospital.
2. ASP shall maintain utmost data confidentiality of such data and shall not share the same with any third party unless and otherwise authorized by hospital
3. ASP shall maintain Turnaround Time (TAT) as agreed by them.
4. ASP shall arrange to provide Ambulance along with driver registered as Ambulance (under the Ambulances act) to the hospital as a required hire basis for shifting of patient to meet the emergencies.



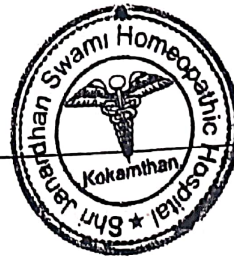

5. Requirements for Ambulance:

- a) The ASP must provide the Ambulance duly registered as per Motor Ambulance Act anywhere in India and having pollution control certificate.
 - b) The Ambulance to be provided shall not be older than MODEL-2011 and well maintained in excellent road worthy condition.
 - c) Documents of Ambulance - The ASP shall produce before the Officer-In-Charge all the requisite documents and the Ambulance which he intends to ply, for inspection, verification and approval before their placement on duty.
 - d) The Ambulance should be comprehensively insured including the drivers and passengers.
 - e) The ASP shall also give an undertaking / acceptance in writing on his letter head that all the terms and conditions of the work -order are acceptable to him.
 - f) No bill shall be processed and no payment shall be made till requisite agreement is executed.
 - g) The ASP shall furnish undertaking that wage payment made to the deployed persons has been as per Minimum Wages Act.
6. ASP has got right to further extend the contract by five years on the same terms and conditions and rates.
 7. Drivers deputed with the Ambulance must be of good character and antecedent, well behaved & neatly dressed in prescribed uniform and he shall possess appropriate valid Driving License of minimum one year experience & all other requisite documents of the Ambulance including pollution control certificate, insurance cover note etc.
 8. The drivers deputed to run the Ambulance must be in prescribed Uniform as Decided by the ASP.
 9. During the contracting period if Ambulance is seized / detained / impounded by Police/transport official or any other Authority for any reasons whatsoever, it will be at the sole risk / responsibility of the contractor. The contractor shall immediately provide another Ambulance in lieu thereof.
 10. The Ambulance deputed shall have comprehensive insurance cover inclusive of passengers and the hospital shall not be responsible for any damage whatsoever to the Ambulance driver or to the third party.
 11. All duties / taxes / fee levied / cess / permit charge whatsoever payable in consideration of the trade or otherwise, for or related thereto, shall be at the cost of the ASP.
 12. If there is any increase in the existing taxes or new taxes are levied by the Govt. during the period of contract, no extra claim shall be paid and all the expenses shall be borne by the ASP. The hospital is not liable to meet such expenses.
 13. The ASP shall obtain all the necessary permits from RTO or any Govt. or Municipal or any other authority that may be required in connection with the hiring.

14. The log-book shall be maintained by the driver of Ambulance. Journey shall be filled up by the person who performs the journey.
15. The time to time maintenance of Ambulances including all spares, consumables and lubricants shall be the responsibility of the ASP.
16. The contractor shall supply the materials in the Ambulance as per list provided by hospital

• BILLS AND PAYMENTS

1. ASP will collect payments for the listed and authorized services rendered to them.
2. ASP shall charge according to the tariff mutually agreed upon and approved by hospital

• QUALITY OF SERVICE

1. The provider shall ensure delivery of the highest quality standards and shall strictly adhere to all medical and ethical practices.
2. The ASP will be held responsible for any errors / omissions related to procedures, processes and / or methodologies pursued by them, in providing Ambulance Services.

PERIOD OF CONTRACT:

This MOU will be valid for Five years from the date of issue of this MOU, i. e. 01.08.2025 to 31.07.2030

The term of this agreement shall be 5 years. The agreement will be reviewed by both parties at the end of the five year period to determine if any additions or changes are required

• COMMENCEMENT & TERMINATION OF THIS AGREEMENT

The agreement will commence from the date on which it is signed and will remain in force for the five Year.

The ASP hereby represents, warrants and covenants that it holds all the requisite licenses and/or registration under the applicable laws and has sufficient qualified manpower, adequate infrastructure (with capacity and ability to augment all that may be necessary to render its Services), testing equipment, devices and tools to provide such Services in accordance with the highest professional standards and shall hold and maintain all such licenses/approvals/registrations at least for the entire Term of this Agreement. The ASP shall ensure that its personnel possess all the requisite qualifications and expertise to perform the Services contemplated under this Agreement.
