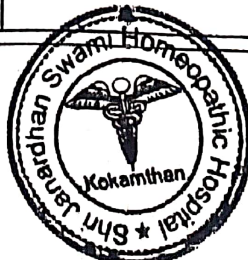

The purpose of this MOU is to define goals and expectations for the relationship between Shri Janardhan Swami Homeopathy Hospital & Research Center and Service Provider as it pertains to the care of Shri Janardhan Swami Homeopathy Hospital & Research Center patients who receive services from Service Provider This MOU will provide a framework for access to services, effective collaboration, and timely communication among Shri Janardhan Swami Homeopathy Hospital & Research Center and Service Provider patients.

#### Goals for Shri Janardhan Swami Homeopathy Hospital & Research Center and Service Provider:

- Provide optimal health care for Shri Janardhan Swami Homeopathy Hospital & Research Center patients in case of Emergency. This includes care that is timely, high quality, and patient-centered.
- Improve collaboration, communication, coordination of services, and continuity of care by supporting efficient, real-time communication of patient information among those caring for the patient.
- Foster healing relationships and patient engagement.

<ul style="list-style-type: none"><li>➤ Provide Service Provider with any necessary medical information for the admission, including medications, chronic diagnosis, etc.</li><li>➤ Be available for phone consultation to assist hospitalist.</li><li>➤ Be available to confer with patient or patient's family when necessary, particularly with serious change in condition.</li><li>➤ Confer with Service Provider to provide list of specialists who have agreed to provide emergency services to Shri Janardhan Swami Homeopathy Hospital &amp; Research Center patients if indicated.</li></ul>	<ul style="list-style-type: none"><li>➤ Review clinical information sent by the primary care provider (PCP).</li><li>➤ At the discretion of the attending provider, contact Shri Janardhan Swami Homeopathy Hospital &amp; Research Center during the hospital admission to discuss any serious complications or change in status and collaborate on recommended plan to support the patient/family, as appropriate.</li><li>➤ Inform patient of diagnosis and prognosis.</li></ul>
Post-Hospitalization

<ul style="list-style-type: none"><li>➤ Contact patient via telephone within 2 business days from discharge.</li><li>➤ Schedule follow-up appointment within 1 week of discharge, for example, within 72 hours for a complex/high risk patient, or 14 days for other patients unless otherwise documented in medical record.</li><li>➤ Resume care of patient on discharge and act on care plan developed by hospitalist or care team.</li></ul>	<ul style="list-style-type: none"><li>➤ Inform patient of follow-up recommendations.</li><li>➤ Through hospital process, contact Shri Janardhan Swami Homeopathy Hospital &amp; Research Center and provide care plan for complex/high risk patients.</li></ul>

## Other terms:

### Compensation

Service Provider will bill the patient. Under the policy in effect as of the date of execution of this agreement, Service Provider will provide medically-necessary hospital inpatient, outpatient and Emergency Department services that are billed by Service Provider and

### Quality of Care

Both Service Provider and Shri Janardhan Swami Homeopathy Hospital & Research Center will furnish their services in a manner that is consistent with, at a minimum, the prevailing standard of care, and the same professional manner and pursuant to the same professional standards as are generally furnished

to all patients, and in accordance with all relevant laws and regulations. Service Provider will accept all Shri Janardhan Swami Homeopathy Hospital & Research Center patients, subject to capacity limitations (as Service Provider may determine in its sole discretion). Each party will provide the other, on request, with assurances that, during the life of this MOU, it and, as applicable, its individual health care practitioners are and will remain duly licensed, certified and/or otherwise qualified to provide services hereunder, with appropriate training, education and experience in their particular field: appropriately credentialed and privileged, and eligible to participate in health care programs.

## Volume or Value of Referrals

Nothing in this MOU requires, is intended to require, or provides payment or benefit of any kind (directly or indirectly) for the referral of individuals or businesses to either Party by the other Party. Neither Party shall track such referrals for purposes relating to setting the compensation of its professionals or influencing their choice.

## Confidentiality

The Parties (and their directors, officers, employees, agents, and contractors) shall maintain the privacy and confidentiality of all information regarding the personal facts and circumstances of their patients in accordance with all applicable laws and regulations (including, but not limited to, the Health Insurance Portability and Accountability Act and its implementing regulations set forth at 45 C.F.R Part 160 and Part 164). The Parties (and their directors, officers, employees, agents and contractors) shall not use or disclose patient information, other than as permitted or required by this MOU for the proper performance of duties and responsibilities hereunder. The Parties shall use appropriate safeguards to prevent use or disclosure of patient information, other than as provided for under this MOU.

## Termination

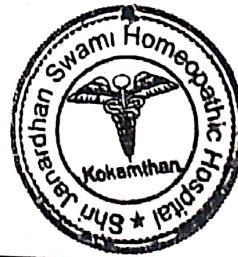
This MOU may be terminated by either Party without penalty or cause by giving written notice to the other Party with one month notice.

If a dispute arises regarding this MOU, Shri Janardhan Swami Homeopathy Hospital & Research Center and Service Provider shall first attempt to resolve it by informal discussions between Parties, unless there are circumstances under which an extended resolution procedure may endanger the health and safety of patients.

## PERIOD OF CONTRACT:

This MOU will be valid for Five years from the date of issue of this MOU, I. e. 01.08.2025 to 31.07.2030
