And

Rashtrasant Janardhan Swami Foundation's, **Shri Janardhan Swami Hospital Pathology Laboratory**, having its Laboratory at **Mumbai - Nagpur Highway, Kokamthan, Tal. Kopargaon** Hereinafter referred to as Health service provider [HSP] (which expression shall unless it is repugnant to the context or meaning thereof shall deem to mean and include its successors or assignees).

WHEREAS, Hospital is a healthcare organization providing various health related services to their clients which includes amongst them insured individuals and groups, corporate, self-funded groups, foreign travelers and insurance companies and for this purpose Hospital has created a network of service providers. The HSP agrees to provide the necessary services on the terms and conditions, herein after appearing:

• **SCOPE OF SERVICES**

- d) **Microbiology with Surveillance Services for OT, Labour room, ICU & Water Culture**

2. HSP shall transmit the data, reports in the specified format as forwarded and strictly as per the guidelines laid down by Hospital and further should retain such data for next 5 years, from the date of reporting without tampering the same.
3. HSP shall maintain utmost data confidentiality of such data and shall not share the same with any third party unless and otherwise authorized by Hospital
4. HSP shall maintain Turnaround Time (TAT) as agreed by them and should inform Hospital within 48 hours about any changes in Facility, Personnel and Address that they undergo.

Critical Result Reporting

HSP will report all urgent & critical results & on priority basis. All critical results will be communicated by HSP to Hospital & same record will be maintained by HSP.

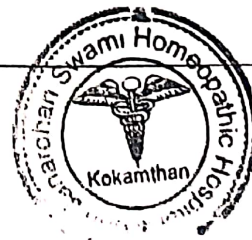
Rest required test results will be communicated by HSP to the Hospital within Four Hrs. except Histopathology, Culture & Sensitivity Test

• MEDICAL HEALTH CHECK-UPS

1. Hospital will inform clients about HSP and their details.
2. HSP will be required to inform client about pre-requisition if any for the test to be conducted.
3. When the reports are ready HSP shall inform Hospital through telephone / fax / email.

• BILLS AND PAYMENTS

1. HSP will collect payments for the listed and authorized services rendered to them.

• QUALITY OF SERVICE

1. The provider shall ensure delivery of the highest quality standards and shall strictly adhere to all medical and ethical practices.
2. The HSP will be held responsible for any errors / omissions related to procedures, processes and / or methodologies pursued by them, in providing Health / Medical Services.

PERIOD OF CONTRACT:

This MOU will be valid for Five years from the date of issue of this MOU, I. e. 01.08.2025 to 31.07.2030

The term of this agreement shall be 5 years. The agreement will be reviewed by both parties at the end of the Five year period to determine if any additions or changes are required.

• COMMENCEMENT & TERMINATION OF THIS AGREEMENT

The agreement will commence from the date on which it is signed and will remain in force for the Five Years.

The HSP hereby represents, warrants and covenants that it holds all the requisite licenses and/or registration under the applicable laws and has sufficient qualified manpower, adequate infrastructure (with capacity and ability to augment all that may be necessary to render its Services), testing equipment, devices and tools to provide such Services in accordance with the highest professional standards and shall hold and maintain all such licenses/approvals/registrations at least for the entire Term of this Agreement. The HSP shall ensure that its personnel possess all the requisite qualifications and expertise to perform the Services contemplated under this Agreement.
