For those UG / PG qualifications that are not yet recognized by the Central Govt., it shall be mandatory for the College to apply to the Central council/Commission through Central Govt. and ensure that "Permitted"/"Not Recognized" qualifications are enlisted in "Recognized Qualifications", failing which University shall not grant Continuation of Affiliation to such courses from ensuing Academic Year & no student shall be admitted in such Courses.

(v) **Deficiencies observed by NCH :** The shortcomings mentioned in paragraph No. 2(a to c) of NCH, New Delhi letter referred above may please be fulfilled and the compliance letter to be forwarded directly to NCH, New Delhi and copy of the same shall be forwarded to the University within a period of 30 days.

Important Note:

- 1) This Conditional Continuation / Extension of affiliation is issued for the A.Y. 2024-2025 subject to the permission of NCH / Govt. of India / Department of AYUSH, New Delhi. Further, if the permission is declined by the said authorities, this Continuation / Extension of Affiliation shall be treated as cancelled. The College is not authorized to admit the students for 1st Year of the course until receipt of permission of the NCH / Govt. of India/ Department of AYUSH New Delhi.
- 2) The admission shall be done through the Competent Authorities only.
